

Terms and conditions

Hotel Eibacher Hof, Nuremberg (22.01.2018)

Please note the following terms and conditions that apply to the contractual relationship between you and us and to which you agree by your booking.

1. Registration

1.1 The guest accommodation contract is completed as soon as the room ordered and promised or, if a commitment for time reasons was not possible.

1.2 The conclusion of the guest accommodation contract obliges the contractual partner for the fulfillment of the contract which time the contract was concluded.

1.3 Reserved rooms are available to the guest from 3 pm

1.4 Unless explicitly agreed upon a later arrival time the hotel reserves the right to reserve reserved rooms after 6 pm.

1.5 If the period between the conclusion of the contract and 180 days, so the hotel reserves the right

The right to make price changes without prior notice.

1.6 Changes in the pro rata value added tax rate are not affected

Of the date of the contract

Of the customer.

2. Benefits

2.1 The Guest shall not be entitled to the provision of certain goods

Rooms or rooms. Agreed rooms

Are not available, the hotelier is obligated to arrange for a

Equivalent replacement in the home or in other objects

To strive.

2.2 A reimbursement of paid, unused

Services are not possible.

3. Rescission

3.1 All withdrawals must be in writing.

3.2 For individual orders outside the large trade fairs, a Cancellation free of charge until 7 days before arrival.

Individual orders for a period within which a Radius of 50 km around the location of the hotel trade fairs Of supraregional importance, can only take place until the 50th day before arrival free of charge.

3.3 Cancellations of groups (from 4 persons) will be charged until 90 Days before the booked day of arrival.

3.4 In case of cancellation of groups from the 89th day before the arrival date 50% will be charged on the room rate. In case of rescission

Between the 14th and 4th day before the arrival day

We give you 70% of the room rate. In case of rescission from 3.

Day before the arrival day we charge the full room

Catering price minus 40% savings on the

Catering price.

3.5 The hotelier is held in good faith, do not claim

The rooms are different

To avoid failures.

3.6 Until the room has been reserved for the guest,

The duration of the contract is the amount calculated in accordance with section 3.4 to pay.

3.7 In so far as there are trade practices which are subject to the conditions laid down in para. 3

Agreements

Agreed that between the contracting parties these trade practices

Should not be valid.

4. Payment

4.1 For group bookings of 12 or more and for reservations

The reservation is only valid for individual guests from abroad

When confirmed with the final order by the

Customer or after confirmation by the hotel within

Of 10 days a deposit of 20% of the booked

Performance.

4.2 Hotel settlements are due on presentation.

4.3 In the event of cancellation in time, advance payments will be fully refunded.

5. Other

The court of jurisdiction is the court of jurisdiction for our company.

Terms and conditions of reservation our conference and banquet rooms

1. The event agreement is concluded with the timely acceptance

By our customer (client) binding on both sides and

Establishes a liability relationship to the fulfillment of the contractual obligations

In equal parts hotel and client. The client

Liable even if he is not with the organizer in the person

Is identical.

2. After the conclusion of the contract a rescission (cancellation) for none of the

Except in the case of unforeseeable higher rates

Violence. Force majeure in this sense is war, internal

Unrest, natural catastrophes, epidemics, fire and on the side of the hotel

Also strike. Lack of number of participants, organizational or similar

Reasons on the part of the client / organizer are not considered higher

Violence.

3. Should the client use the services of the hotel after contract conclusion

(Cancellation by the customer) and the

Hotel's shared capacities during the agreed reservation period

Can not be rented at the same rate,

The customer undertakes to pay the handling costs

According to the event agreement.

In addition, the hotel can be canceled by the client

Between the 8th and 14th day before the first day of the event

Percent of the expected F & B sales (food and drinks),

Between the 3rd and 7th day before the first day of the event eighty

Percent of the expected F & B sales and during the last
